Director's Updates	Amanda Perkins has left UArizona and is no longer working as Finance Manager for AzAHEC. Replacement candidates are actively being sought. If Centers and RHPPs have questions in the interim, please email Leila Barraza or Jennifer Zuniga as there is no alternative financial contact at the moment. A few years ago, AHEC began soliciting a Request For Proposal (RFP) from AHEC Centers. This is because of State of Arizona requirements that indicated the need to seek RFPs for any contracts over \$100K. This process, which impacts Regional Centers, is being put on hold until Amanda Perkins' position is filled. Center directors will be advised when this process resumes. Roy Sanchez has joined the AHEC Program Office. Colleen Reed continues with the AHEC Program Office in a different capacity. The AHEC Program Office received funding last year from the state legislature for Graduate Medical Education (GME) efforts toward increasing the number of residencies in rural areas, rural health clinics, tribal 638 clinics, and community health centers. Since these efforts require additional staffing assistance, and increasing amount of Colleen's work will support these GME efforts.	Leila Barraza
Financial Report	A summary was provided of the Year-to-Date Financial Report for the quarter ending December 31, 2023.	Leila Barraza
Additional Updates	AHEC receives funding from HRSA and the State of Arizona. HRSA has very specific reporting requirements, and both Center and RHPP data are reported to HRSA. The midyear assessment report is generated annually so that AHEC can assess achievements that will ultimately be reported. In the Commission packet, there is a summary of Center reported data, followed by a summary of RHPP reported data, and concludes with a combined summary of Center and RHPP reported data. This data signals that AHEC is on course to achieve the required HRSA annual performance goals.	Jennifer Zuniga



SAAHEC is presently working on CME, which has a summit on May 8. All present efforts from SAAHEC are predominantly focused on this event in collaboration with El Rio and other community partners. For clinical rotations, SAAHEC continues to provide graduates with stipends and housing support in rural areas. SAAHEC has hired a new program coordinator, Tiffany Bedford, to assist with Pipeline programs. After getting up to speed, Tiffany will assist SAAHEC with achieving program deliverables.

WAHEC is presently focusing on the distribution of CME, including on the subject of breast cancer. WAHEC is also working on a nutrition series involving culinary medicine. Regarding Pipeline programs, WAHEC is currently finalizing LIC schedules, which will include culinary medicine as an elective. WAHEC is currently assisting PPEP TEC schools in their efforts to build clubs. A large batch of data regarding Pipeline HOSA students will soon be processed. WAHEC is also working on GME and planning a residency program to open in July of 2025.

As a reminder, funding for residency programs at community health centers, rural health clinics, and tribal 638 come from a different funding source. This is a separate AHEC program and will not be included in the Center AHEC budget reports.

CERE has spent a tremendous amount of time developing new tracking and reporting systems that are proving to be very helpful. Scholars have excelled and completed required papers, posters, and podcasts. CERE is deeply involved in residency and LIC programs. Three new residential units have been added to CERE's housing portfolio, which provides an advantage in bringing students to Payson.

Kenny Evans

CAAHEC is working with health care centers to aid students in completing CBETs. Pipeline students are active. CAAHEC is also actively planning a Pace Conference and research mentor programs. A new Introduction to Public Health program is beginning in March. CMEs are continuing to take place, and multiple events have been planned with ADHS, BCBS, and the Maricopa County Department of Public Health. One improvement CAAHEC has made involves the automation of certificates for the CME program. CAAHEC has a vacancy in the CME team, which is being worked on.

Shelli Stewart

AlH-AHEC is expanding and has hired a new professional development coordinator who will be working with CE and CPD. New clubs are being established with Native Health, and new HOSA clubs are being developed. AlH-AHEC also continues to support San Carlos Apache Health Care and Gila River Healthcare with their summer programs. The AlH-AHEC website is progressing as a tool for advertising and as a means to provide resources. An American Indian Health advisory council has been established. Many of AlH-AHEC's year one strategic infrastructure goals are coming to fruition.

CPCHP is presently developing a new psychiatry residency. A match rank list was recently submitted for CPCHP's Family Medicine Residency Program. CPCHP is planning to expand the family medicine program. CPCHP has either accomplished or is close to accomplishing the annual metric requirements for CBETS. CPCHP has created a toolkit for preceptors which provides guidance and best practices regarding charting, providing feedback, contact information

	and workflows. CPCHP is developing a new public health and community medicine rotation with the UA MDMPH. Regarding CE and CME, CPCHP is preparing for annual clinician conferences and work force development programs. CPCHP is preparing for the second year of the Tuba City High School Exploration program, which is an expansion of the Indigenous Pride Health Workers program, which CPCHP has been collaborating on for 20+ years. CPCHP is also working on the 3 rd year of the Future Faces of Family Medicine program, which will have clinical shadowing added to the curriculum this semester. The immersions for AHEC Scholars were recently completed with one cohort in Williams and the other in Show Low.
